**BE IT RESOLVED**, That Montcalm Community College's in-district tuition is set at \$121 per contact hour, out-of-district tuition is set at \$231 per contact hour, out-of-state tuition is set at \$378 per contact hour, in-district nursing tuition is set at \$156 per contact hour, out-of-district nursing tuition is set at \$266 per contact hour, out-of-state nursing tuition is set at \$413 per contact hour and MCC's College Services Fee is set at \$18 per contact hour and MCC's Technology Fee is set at \$25 per contact hour effective with the fall 2024 semester.

The Trustees reviewed the 2024-25 tentative budget highlights.
